The first World Logic Day celebration organized by the *Peruvian Society for Epistemology and Logic* was an academic event called *The Heterodox in Logic and Reason*. Most talks were based on the legacy of José Francisco Miró Quesada Cantuarias (1918-2019), who was the Peru's most important philosopher of logic and mathematics.

Miró Quesada's main concern was to construct a theory of reason adequate for understanding the most important logical and mathematical discoveries of his time: Gödel's incompleteness theorems and heterodox logics. His main topics of interest were philosophy of logic and mathematics, theory of reason, logic and metaphysics, non-classical, heterodox and paraconsistent logics, deontic logic and logic of law, among others.

This event not only included speakers from several continents, and several generations, but we also were privileged to have living legends in the fields of philosophy and history of logic, such as Evandro Agazzi and Walter Redmond.

The heterodox in logic and reason is also the name of a special issue of the *South American Journal of Logic*, which is also dedicated to Francisco Miró Quesada Cantuarias (<u>https://spel.org.pe/sajl-2021</u>).
